#### Explanatory note 4

**Regular worshippers** - if applying under criterion 5, the Governors require that the Supplementary Information Form (SIF **B**) be signed by the Minister of the church or other place of worship. Regular worship means that at least one parent/carer regularly attends services at least once per month over a minimum period of one year immediately preceding the date of application. In cases of re-location, it will be necessary to provide documentary evidence of the same pattern of attendance. If a SIF is not submitted at the time of application, on time, the child may be ranked in a lower criterion. In the event that during the period specified for attendance at worship, the church has been closed for public worship and has not provided alternative premises for that worship, the requirements of these [admissions] arrangements in relation to attendance, will only apply to the period when the church or alternative premises have been available for public worship.
